

The Fee collected by whatsoever name called either for University quota seats or for management quota seats should not exceed the limits specified by the State Government/Kaloji Narayana Rao University of Health Sciences, TS, Warangal from time to time.

The Management shall follow the regulations made by the University/State Government and also the Regulations on Graduate Medical Education (Amendment),2019 of the Medical Council of India/NMC in making admissions, in conducting examinations and in respect of all other related matters from time to time. Any deviation, in this regard may lead to disaffiliation of the college without any notice. This order is valid for the academic year 2023-24 only.
